Coordinator and Lecturer at the Los Angeles office of the National Bullying Prevention Center, where she coordinates outreach and gives presentations, webinars, and workshops to schools, health organizations, and other community groups. Her speaking engagements have reached over 30,000 students, parents, educators, & community leaders throughout Southern California and beyond. She has facilitated and presented workshops for many years throughout the country on communications skills, conflict resolution, relationship building, leadership, and self-advocacy.

Ms. Barbara Spears

Project Advisor & Professor of Education and Social Development (Adjunct), UniSA Education Futures, and an active member of Centre for Research in Educational and Social Inclusion (CRESI). Her career has spanned over 45 years as an educator in both primary and tertiary settings. She is known nationally and internationally for her leadership in bullying and cyber-bullying research, including work on youth voice, mental health and wellbeing, with hundreds of peer refereed publications; government reports, invited keynotes and community presentations. She is an inaugural member of, and recent Deputy Presiding Officer of the Child Development Council of SA, and Chair of the Charter for Children and Young People sub-committee. Barbara is also Chair of the Australian Universities' Anti-Bullying Research Alliance (AUARA) which advises government on policy and practices related to student wellbeing. She led the Review of the National Safe Schools Framework which has resulted in the current Australian Student Wellbeing Framework.

Ms. Deborah Green

Senior researcher with decades of work across two key strands: persistent bullying, bullying and cyber-bullying; and contemporary pedagogies that maximise diverse student engagement. Key areas of influence and interest include the roles of turning points and resilience; inclusive education and disability studies. She is also a Senior Lecturer in Education Futures, with a strong alliance to the teaching profession and a leader in teacher education for 18 years. Deborah was the Program Director of the largest Initial Teacher Education program in South Australia. She is an active member of the Centre for Research in Educational and Social Inclusion (CRESI); Executive Secretary and Executive Committee member of Social and Citizenship Education Association of Australia Inc.; Founder of HaSS Association of Australia; and South Australian representative for the Network of Associate Deans of Learning and Teaching in the Discipline of Education (NADLATE).
